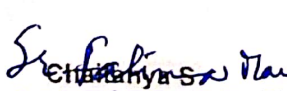
After careful examination of the proposals from the society and also the inspection report of the inspecting officer in the reference 1st cited, under rule 3(i)(a) of GO 3rd cited above, permission is hereby accorded for grant of renewal of recognition for Classes I to V (EM) in respect of **J.M.J.School (English Medium) School, Kanchili (Vill) Mandal, Srikakulam District** from the academic year 2025 -2026 to 2032-2033 subject to the following conditions and in view of the provisions contained in the 3rd and 6th cited

1. That the society shall abide by the instructions/rules and regulations made by the Government or authorized Officer from the time to time.
2. That the Educational Institutions shall serve the needs of the locality more particularly.
3. That the institution shall adopt the curriculum and syllabus prescribed by the Government from time to time.
4. That the school timing vacations and mid – term holidays shall be followed as prescribed by Government from time to time.
5. That the qualified staff within the age limits prescribed by Government employees shall be appointed with the management own funds as per staff pattern.
6. That the results of institution shall be satisfactory every year.
7. That the records / accounts shall be furnished to the District Educational Officer, every year by 30th September at least.
8. That the list of Governing Body shall be furnished to the District Educational Officer every year.

9. That the pay structure / fee structure fixed by the Governing Body shall be got approved by the District Educational Officer every year.
10. That all the conditions prescribed in the G.O.'s and other orders which are not specified in this order shall be complied with
11. That the school shall not be closed without giving notice both to the parents / District Educational Officer, and competent authority at least six months before.
12. That the school shall be closed or permitted to be closed only from the date which summer vacation is declared.
13. That the society shall submit proposal for Renewal of recognition sufficiently in advance i.e., at least six months prior to the date of expire of the present recognition.
14. That the society shall provide fire safety measures in the school as per the No objection certificate.
15. The management is hereby informed that no thatched roof accommodation is allowed to run the school.
16. Proper and adequate sanitation facility shall be provided for students especially for girl students.
17. The school shall follow the traffic and safety measures shall be taken for children within the school campus and also near the school premises.
18. The school shall follow the traffic and safety guidelines indicated by the police and fire services, Departments.
19. The parent teachers' associations meeting be conducted to sensitize the parents on the safety of the children.
20. The school shall have first aid kit and the teachers shall be trained in first aid.
21. The Correspondent of the concerned school is hereby informed to file an affidavit every year to the effect that there is no deviation or violation of norms prescribed by the Government from time to time.
22. That the management shall obtain and submit the structural soundness certificate every year before reopening of the school for the academic year.
23. That the management shall take every responsibility for the timely, safe and comfortable mobility of the School Children from the residences to School and vice versa.
24. That the School Van should be ensured road worthy for the transportation mobility of school children.
25. That the school van should be free from all taxes due and should be maintained with regular checks by authorized mechanics periodically / as and when required without causing any sort of dislocation for the school children opting the van facility.
26. That the management shall engage skilled experienced and authorized drivers having good health and good vision for the school vans.
27. That the management shall insure the vehicle and safety grills be provided to all the windows of the vehicles without fail.
28. That management shall ensure the accounts of the school audited by an authorized chartered accountant every year and submit.
29. The management shall have to follow the rules and guidelines issued to Go.Ms.No.91, Edn., Dt.06.08.2009 regarding fee structure in private Schools.
30. The management is hereby instructed to follow the G.O Ms.No.01 and subsequent G.Os / memos issued from time to time without any deviation.
31. Any deviation of the norms / guidelines issued from time to time will be viewed seriously. Receipt of these proceedings should be acknowledged

Previously Renewal of Recognition has been accorded to the classes VI to X (EM) to JMJ (EM) High School, Kanchili (VII) & (Mandal), Srikakulam District for the years from 2009-10 to 2018-19 vide Proge.Re.No.5694/B1/2008, Dated 29.12.2008 of the Regional Joint Director of School Education, Kakinada.

Now the Secretary & Correspondent, JMJ (EM) High School, Kanchili (VII) & (Mandal), Srikakulam District has submitted the application for Renewal of Recognition for classes VI to X (EM) for the years from 2019-20 to 2028-29 vide reference 5th cited. In the reference 7th cited, the District Educational Officer, Srikakulam has verified the application for Renewal of Recognition and recommended from 2018-19 to 2027-28 instead of 2019-20 to 2028-29 erroneously with reference to the Inspection Report of the Inspecting Officer (vide reference 6th cited) and as per the G.O.Ms.No.1 Education, Dated 01.01.1994.

Under Rule 3 (2) of G.O.Ms.No.1 Education, Dated 01.01.1994, the Regional Joint Director of School Education, Visakhapatnam who is the competent authority is hereby accorded Renewal of Recognition to the JMJ (EM) High School, Kanchili (VII) & (Mandal), Srikakulam District for a period of '10' (Ten) years i.e., for the academic years from 2019-2020 to 2028-29 for the classes VI to X (EM) based on the report of the District Educational Officer, Srikakulam subject to fulfillment of the following conditions.

- 01 That the society shall abide by the rules and regulations made by the Government or authorized officer from time to time.
- 02 That the Educational Institutions shall serve the needs of the locality more particularly.
- 03 The institution shall adopt the curriculum and syllabus prescribed by the Government from time to time.
- 04 That the school timings, vacations and mid-term holidays shall be followed as prescribed by Government from time to time.
- 05 That the qualified staff within the age limits prescribed by Government for Government employees shall be appointed by the management with own funds as per the staff pattern.
- 06 That the results of institution shall be satisfactory every year.
- 07 That the records / accounts shall be furnished to the District Educational Officer, every year by 30th September at least.
- 08 That the list of Governing Body shall be furnished to the District Educational Officer every year.
- 09 That the pay structure / fee structure fixed by the Governing Body shall be got approved by the District Educational Officer every year.
- 10 That all the conditions prescribed in the said G.O.'s and other orders which are not specified in this order shall be complied with.
- 11 That the school shall not be closed without giving notice both to the parents / District Educational Officer and competent authority at least six months before.
- 12 That the school shall be closed or permitted to be closed only from the date on which summer vacation is declared.
- 13 That the society shall submit proposal for Renewal of recognition sufficiently in advance i.e., at least six months prior to the date of expiry of the present recognition.
- 14 That the society shall provide fire safety measures in the school as per the No Objection Certificate.
- 15 The management is informed that no thatched roof accommodation is allowed to run the School.
- 16 The management shall provide proper adequate Toilets / sanitation facility to the students & Staff.
- 17 Proper and adequate safety measures shall be taken for the students within the school campus and also near the school premises.
- 18 The school shall follow the traffic and safety guidelines indicated by the Police and fire services departments.
- 19 The parent Teachers Associations meeting shall be conducted to sensitize the parents on the safety of the students.
- 20 The school shall have first aid kit and the teachers shall be trained in first aid.
- 21 That the management shall obtain and submit the structural soundness certificate every year before reopening of the school for the academic year to the Inspecting Officer concerned without fail.
- 22 The management of the school is hereby informed to renew sanitary certificate from the competent authority every year and same should be submitted to the District Educational Officer, Srikakulam through the inspecting officer.
- 23 The management of the school is hereby instructed to renew the Fire NOC every year without fail.
- 24 That the management shall ensure the Accounts of this school are audited by an authorized Chartered Accountant every year.
- 25 That the management has to maintain trained and qualified of APTET Teachers at all time.
- 26 The Management is hereby informed to file an affidavit before April 30th of every year to the effect that there is no deviation or violation of norms prescribed by the Government from time to time.

If the management fails to comply with the above conditions promptly the Recognition now granted will be reviewed.
